## Section 2 - Hazards Identification

### Statement of Hazardous Nature

This product is classified as: Not classified as hazardous according to the criteria of SWA.

### Emergency Overview

**Physical Description & colour:** Brown powdered solid.

**Odour:** Mild wood odour.

**Major Health Hazards:** no significant risk factors have been found for this product.

### Potential Health Effects

#### Inhalation:

**Short term exposure:** Long term inhalation of high amounts of any nuisance dust may overload lung clearance mechanism. Available data indicates that this product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

**Long Term exposure:** No data for health effects associated with long term inhalation.

#### Skin Contact:

**Short term exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. In addition product is unlikely to cause any discomfort in normal use.

**Long Term exposure:** No data for health effects associated with long term skin exposure.

#### Eye Contact:

**Short term exposure:** This product is likely to be mechanically irritating. If exposure is minor or brief, no long term effects should result. However, if material is not removed promptly, scratches to surface of the eye may result with long term consequences.

**Long Term exposure:** No data for health effects associated with long term eye exposure.

#### Ingestion:

**Short term exposure:** Significant oral exposure is considered to be unlikely. However, this product may be mildly irritating to mucous membranes but is unlikely to cause anything more than mild transient discomfort.

**Long Term exposure:** No data for health effects associated with long term ingestion.

#### Carcinogen Status:

**SWA:** No significant ingredient is classified as carcinogenic by SWA.

**NTP:** No significant ingredient is classified as carcinogenic by NTP.

## Section 3 - Composition/Information on Ingredients

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

## Section 4 - First Aid Measures

### General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this MSDS with you when you call.

**Inhalation:** First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

**Skin Contact:** Gently brush away excess solids. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

**Eye Contact:** Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water until the particles are removed, while holding the eyelid(s) open. Obtain medical attention if irritation persists, or if particles are lodged in surface of the eye(s). Take special care if exposed person is wearing contact lenses.

**Ingestion:** If product is swallowed or gets in mouth, do NOT induce vomiting; wash mouth with water and give some water to drink. If symptoms develop, or if in doubt contact a Poisons Information Centre or a doctor.

## Section 5 - Fire Fighting Measures

**Fire and Explosion Hazards:** There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. This product, if scattered, may form flammable or explosive dust clouds in air.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

**Extinguishing Media:** Preferred extinguishing media are carbon dioxide, dry chemical, foam, water fog.

**Fire Fighting:** If a significant quantity of this product is involved in a fire, call the fire brigade. Do not scatter spilled material with high pressure water jets.

**Flash point:** Combustible solid.

**Upper Flammability Limit:** No data.

**Lower Flammability Limit:** No data.

## Section 6 - Accidental Release Measures

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include cotton, rubber, PVC. If there is a significant chance that dusts are likely to build up in cleanup area, we recommend that you use a suitable Dust Mask.

Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Consider vacuuming if appropriate. Recycle containers wherever possible after careful cleaning. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

## Section 7 - Handling and Storage

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. ## Section 10 - Stability and Reactivity

**Reactivity:** This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

**Conditions to Avoid:** Containers should be kept dry.

**Incompatibilities:** strong oxidising agents. Contact with vegetable oils and essential oils may cause considerable heat build, possibly leading to spontaneous combustion. We recommend that you do not use this product in cleaning up that type of spill.

**Fire Decomposition:** Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Water. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

**Polymerisation:** Polymerisation reactions are unlikely; they are not expected to occur.
